ON JAN 1st the popular herb St. John's Wort (hypericum) became a prescription-only medicine in the Republic of Ireland. Formerly widely available in health stores, severe penalties can now await anyone guilty of the crime of freely selling it.

Gingko Biloba is another extremely beneficial herb, which was made prescription-only in Ireland some time ago, on absolutely no evidence and with little protest at the time.

The end result so far is that at present doctors don't actually use them while health stores cannot sell them: so they are effectively banned.

They have also been gifted to the pharmaceutical industry as exclusive products for future promotion. Compare the situation in Germany where the choice in health stores is very limited and the pharmacies control most vitamins etc. ON JAN 1st the popular herb St. John's Wort

St. John's Wort is an effective herbal treatment for mild to moderate depression, a point admitted by former Minister for Health Mr. Cowen, in speaking to the Dail. Both the Irish Medicines Board and Mr. Cowen have stated that they consider the treatment of mild to moderate depression should be a matter for doctors only, and that this was the major reason for its banning. There is no basis in Irish law for this statement and the IMB are greatly exceeding their remit in saying so. What, you may wonder, are psychotherapists, exercise therapists, massage therapists and nutritionists to make of such a statement? Such therapists are likely to provide far better treatment for depression than a doctor.

The original purpose of the "prescription-only" list was to control poisonous substances and dangerous drugs - now it is being used politically to imit and restrict the health food industry. There is no good evidence to substantiate charges of damaging side-effects due to either of these herbs.

Let us be watchful of this process. For want of vigilance, people in countries such as Norway, Germany and Italy have been deprived of the development of the vibrant, high-tech health and fitness foods retailing that is now one of America's greatest growth industries.

In 1991 the Tony Quinn Health Centres with the Irish Association of Holistic Medicine campaigned to prevent the application of draconian regulations which would have destroyed the availability of food supplements in Ireland. By taking our case to the Minister and a Committee of the Dâil at the time it was agreed that existing consumer protection laws were sufficient protection for the public, and that has been the situation until now.
